**VACANCIES FOR THE POST OF AGMs FOR**  
**HEADQUARTERS & RO GORAKHPUR**

1. Applications are invited from retired Short Service/Regular Commissioned Officers of the rank of Major/Lt Col/Col or their equivalent from Indian Air Force and Indian Navy for the following posts :-

(i) **AGM (Operation & Business Development)**

- (a) Shall be of the rank of a Lt Col/Col or their equivalent from the IN and IAF and should have at least 20 years of military service.
- (b) Regular MBA Degree and Corporate experience will be preferred.

(ii) **AGM (Legal & Corporate Affairs)**

- (a) Retired officers from JAG Branch of the rank of Maj/Lt Col/Col or their equivalent rank officers from the Indian Navy & Indian Air Force or other officer holding a Law Degree (LLB) with at least 10 years of legal services/work experience.
- (b) Corporate experience and officer with license to practice in court of law will be preferred.

(iii) **AGM (Project & Designs)**

- (a) Should be a retired officer of the rank of Lt Col/Col ex Corps of Engineers or their equivalent rank officers from the Engineering Branches of the Indian Navy & Indian Air Force and having served for a minimum period of twenty (20) years in Armed Forces.
- (b) Should be in possession of a *Degree in Civil Engineering* from a recognized University.
- (c) Officers with experience in MES as Garrison Engineers/Chief Works Engineer would be preferred.

(iv) **AGM (Operation), Regional Office Gorakhpur**

- (a) Shall be of the rank of Lt Col/Col from Indian Army or their equivalent from Indian Air Force and Indian Navy for the post of AGM (Operations) for our Regional Office at Gorakhpur.

2. Applicants *should submit their application by email as well as by speed post* along with self attested scanned copies of the under mentioned documents:-

- (a) Curriculum Vitae.
- (b) PPO, ESM Service booklet issued by the concerned Service Headquarters.
- (c) ESM Identity Card, ECHS & CSD smart cards, Aadhar and PAN Cards.
- (d) Copies of all educational and other skills acquired certificates.

**For Serving/Re-employed Officers Only**

3. In addition to the documents mentioned at para 02 above, Serving /Re-employed Officers must also submit their record of service duly countersigned and *must give an undertaking on a Rs 100/ Non Judicial stamp paper that they shall join duty within 30 days of letter of offer made to them and that they shall be located/based at Lucknow/Gorakhpur* ; only then their applications will be processed for interview. *If such an undertaking is not received, their applications shall not be processed and they shall be ineligible for interviews for the selection.*

4. **If selected, serving/re-employed Officers must join duty within 30 days of letter of offer made to them, failing which the offer shall stand cancelled.**

5. The initial employment probation period shall be for a period of three months. If at the end of three months probation period the performance is not satisfactory the probation period could be terminated/extended. If found fit during probation period the contract may be extended for a period of eleven months on the basis of performance during the probation period.

6. Interview dates likely be end of June 2020. Interview dates will be intimated on e-mail as well as telephonically well in advance. Officers who are absent on the date of interview shall not be entertained at any later date. Out station Officers are requested to make own arrangements for stay when called for interview.
